## SUMMARY ANNUAL REPORT FOR JUNIATA COLLEGE HEALTH & WELFARE BENEFITS PLAN

This is a summary of the annual report of the Juniata College Health & Welfare Benefits Plan, a health, life insurance, dental, vision and long-term disability plan (Employer Identification Number 23-1352652, Plan Number 501), for the plan year 01/01/2021 through 12/31/2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## **Insurance Information**

The plan has insurance contracts with AFLAC, Ameritas Life Insurance Corp., Colonial Life & Accident Insurance Company, Principal Life Insurance Company, Vision Benefits Of America, Hartford Life and Accident Insurance Company and Symetra Life Insurance Company to pay certain Temporary disability, Supplemental, Dental, Life insurance, AD&D, Cancer, PPO contract, Indemnity Contract, Vision, Health, Long-term disability, AD&D claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2021 were \$887,970.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2021, the premiums paid under such "experience-rated" contracts were \$40,265 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$0.
